- The Candidate shall not claim regular appointment at this Institute, as the post is co-terminus with the project.
- The candidates will have to compulsorily bring the filled in application form (As per the format annexed), all the original certificates from matriculation onwards, date of birth certificate, NET/equivalent certificate, degree certificate either original or provisional and one set of the self- attested photocopies of all the required certificates from matriculation
