(1) Faculty Upgradation Scheme (FUS), (2) ICAR In-Service Scheme, (3) Departmental (Scientific and Technical) Scheme, (4) Children/Widows of Security Forces (CWSF) Scheme, (5) Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (Non-Migrants) living in Kashmir Valley and (6) National Fellowship holders (CSIR/UGC/DBT/GATE/DST).

### Educational Qualification and other Eligibility Requirements for Different Schemes

The candidates declared/notified as eligible for counseling by ICAR/NTA, based on their merit-rank and National Fellowship holders (CSIR/UGC/DBT/GATE/DST), shall fill up Application Form and upload required documents online for PG/Ph.D. degree programme under Different Schemes. Candidate shall forfeit the claim for admission if he/she does not fill up application form and upload required documents within the specified date and time. Those candidates, who have scored zero or negative marks or have not been declared/notified as eligible for counseling, shall not be considered for admission under Different Schemes at IARI, New Delhi for the academic session 2025-26 at any stage.

- (ii) Documents related to Eligibility Requirements shall not be checked during the filling up of application form online but will be verified after the filling up of Application Form/uploading of required documents process is over. Candidates are required to ensure that they fulfill all the eligibility and document requirements for the Sub-subject at IARI, New Delhi as given in the ICAR AIEEA (PG)- 2025 and ICAR AICE-JRF/SRF-(Ph.D)-2025 Information Bulletin respectively available on <a href="https://icarcounseling.com">https://icarcounseling.com</a> website. Candidates will be solely responsible for their fulfilling of and compliance to these eligibility and document requirements. The IARI will not entertain any claims arising out of their failure to comply with these requirements even at a later stage.
- (iii) The Merit list will be prepared for each of the Scheme separately for the eligible candidates who will fill up application form and upload required documents Online. The Candidate will be provisionally recommended for admission in the Sub-subject under a Major Subject Group at IARI, New Delhi on the basis of their "OVER ALL RANKING" across the Disciplines secured in the ICAR AIEEA (PG)- 2025 and ICAR AICE-JRF/SRF-(Ph.D)-2025 Entrance Examination conducted by NTA for M.Sc./M.Tech. and Ph.D respectively.
- (iv) Candidates who have been found qualified in the entrance examination ICAR AIEEA (PG)- 2025 and ICAR AICE-JRF/SRF-(Ph.D)-2025 for M.Sc./M.Tech. and Ph.D. degree programme conducted by NTA/ICAR and National Fellowship holders (CSIR/UGC/DBT/GATE/DST) are eligible to fill up application form and upload required documents under Different Schemes at IARI, New Delhi for the academic session 2025-26.
- (v) In case any degree from a particular College/University being derecognized by VCI/UGC, or due to any court directives (present or future), IARI will not admit such candidates of that College/University.

Rest of the rules/regulations as given in the Information Bulletin ICAR AIEEA (PG)- 2025 and ICAR AICE-JRF/SRF-(Ph.D)-2025 (<a href="https://icarcounseling.com">https://icarcounseling.com</a>) shall be applicable for admission to M.Sc./M.Tech. and Ph.D. degree programme under Different Schemes at IARI.

#### **DIFFERENT SCHEMES**

#### 1. Faculty Upgradation Scheme (FUS)

Admission of In-service Faculty Members of State Agricultural Universities (SAUs) under Faculty Upgradation Scheme (FUS)

Number of Seats: 10 for Ph.D. degree programme ONLY

- i. The Faculty Members applying under this scheme should be regular employees of the State Agricultural Universities (SAUs).
- ii. Not more than three candidates of any one State Agricultural University shall be admitted in any one year under this Scheme.
- iii. Not more than one seat shall be allotted to a particular discipline. However, the number of seats is interchangeable subject to a maximum of two seats per discipline in case of non-availability of candidates in that particular discipline.
- iv. The words "Application for admission under Faculty Upgradation Scheme" should be clearly inscribed on the application and on the forwarding letter. The declaration as given at Annexure- I duly signed by the Vice-Chancellor or his/her nominee should be attached with the hard copy (print out) of online filled application form.

#### 2. ICAR- In Service Scheme

Admission of Scientists working in ICAR Institutes under ICAR - In service Scheme

Number of Seats: 10 for Ph.D. degree programme

- i. The candidates applying under this scheme should be Scientists working in ICAR Institutes.
- ii. Not more than one seat shall be allotted to a particular discipline. However, the number of seats is interchangeable subject to a maximum of two seats per discipline in case of non-availability of candidates in that particular discipline.
- iii. The words "Application for admission under ICAR In Service Scheme" should be clearly inscribed on the application and on the forwarding letter. The declaration as given in Annexure-I duly signed by the Director of the concerned ICAR Institute should be attached with the hard copy (print out) of online filled application form.

#### 3. Departmental (Scientific and Technical) Scheme

Admission under this scheme is for Scientific and Technical staff working at IARI, New Delhi and Regional Stations, ICAR-IASRI, New Delhi, ICAR-NBPGR, New Delhi and ICAR-NIPB, New Delhi.

Number of Seats:

i) Departmental (Scientific):

10 seats for Ph.D degree programme

ii) Departmental (Technical):

05 seats for Ph.D degree programme

05 seats for M.Sc./M.Tech. degree programme

- i. Not more than one seat shall be allotted to a particular discipline. However, the number of seats is interchangeable subject to a maximum of two seats per discipline in case of non-availability of candidates in that particular discipline.
- ii. The words "Application for admission under Departmental (Scientific)/Departmental (Technical) Scheme" should be clearly inscribed on the application and on the forwarding letter which should be attached with the hard copy (print out) of online filled application form.

#### 4. Children/Widows of Security Forces (CWSF) Scheme

Number of Seats: 05 Seats (02 for Ph.D. degree programme and 03 for M.Sc./M.Tech.) (The number of seats for admission to Ph.D. is inter-changeable in case of non-availability of candidates in that particular degree programme).

Seats under this Scheme are to be filled as per the following order of priority:

Priority I : Widows/Wards of Defence personnel killed in action.

Priority II : Wards of disabled in action and boarded out from service.

Priority III : Widows/Wards of Defence personnel who died while in service with death

attributable to military service.

Priority IV : Wards of disabled in service and boarded out with disability attributable to

military service.

Priority V : Wards of Ex-serviceman and serving personnel who are in receipt of Gallantry

Awards:

(i) Param Vir Chakra; (ii) Ashok Charka; (iii) MahaVir Chakra; (iv) Kirti

Chakra; (v) Vir Chakra; (vi) Shaurya Chakra; (vii) Sena, Nau Sena, Vayu Sena

Medal; (viii) Mention-in-Despatches

Priority VI : Wards of Ex-serviceman.

Priority VII : Wives of:

(i) Defence personnel disabled in action and boarded out from service.

(ii) Defence personnel disabled in service and boarded out with disability

attributable to military service.

(iii) Ex-serviceman and serving personnel who are in receipt of Gallantry

Awards.

Priority VIII : Wards of Serving Personnel.

Priority IX : Wives of Serving Personnel.

i. Not more than one seat shall be allotted to a particular discipline. However, the number of seats is interchangeable subject to a maximum of two seats per discipline in case of non-availability of candidates in

that particular discipline.

ii. The words "Application for admission under Children/Widows of Security Forces Scheme" should be clearly inscribed on the application which should be attached with the hard copy (print out) of online filled application form.

## 5. Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (Non-Migrants) living in Kashmir Valley

Number of Seats:

05 for Ph.D. Degree Programme

05 for M.Sc./M.Tech. Degree Programme

- i. Not more than one seat shall be allotted to a particular discipline. However, the number of seats is interchangeable subject to a maximum of two seats per discipline in case of non-availability of candidates in that particular discipline.
- ii. The words "Application for admission under Wards of Kashmiri Migrants and Kashmiri Pandits/ Kashmiri Hindu families (Non-Migrants) living in Kashmir valley" should be clearly inscribed on the application which should be attached with the hard copy (print out) of online filled application form.

#### 6. National Fellowship holders (CSIR/UGC/DBT/GATE/DST) Scheme

Admission of National Fellowship holders (CSIR/UGC/DBT/GATE/DST) under this Scheme

Number of Seats: 52 for Ph.D. degree programme

- i. Admission of these students will be non-residential.
- ii. Essential qualifications for admission will be followed as per ICAR/IARI guidelines.
- iii. There are total 52 Ph.D. seats (2 seats in each discipline) at ICAR-IARI, New Delhi and its sister institutes. Seat(s) which remain vacant in one discipline will be transferrable to other disciplines having more number of applicants subject to ceiling of maximum 5 seats for a particular discipline.
- iv. Category Reservation will be applicable as per UGC/Govt. of India guidelines.

v. Selection of the candidates will be based on the overall final merit of a candidate (Academic Score and Interview) across the disciplines and candidate with higher merit across the disciplines will be offered the remaining vacant seats after filling of seats in each discipline.

- 1. Essential Education Qualification: Academic: Maximum Marks: 75 (10<sup>th</sup>: 10; 12<sup>th</sup>: 15; Graduation: 20; Post Graduation: 30)
- 2. Interview: Maximum Marks: 25
- 3. Total Marks: 100
