NOTIFICATION

All the candidates who have been provisionally admitted for Doctor of Philosophy course (Ph.D.) for academic session 2025-26 at ICAR-IARI, New Delhi and its off-campuses viz., (1) IIHR Bengaluru, (2) CIAE Bhopal, (3) IIAB Ranchi, through online counselling conducted by Education Division, ICAR, New Delhi are directed to report at their respective campus for physical document verification on 27th November 2025 at 10:00 AM. Students selected for IARI, New Delhi should report at Dr. M. S. Swaminathan Library, IARI, New Delhi and students selected for IARI off-campuses should report at their respective place.

The provisionally admitted candidates shall produce all the original documents and 02 sets of selfattested photo copies of degrees, 2 passport size photos, Certificates and Mark Sheets of all the examinations starting from Matriculation onwards to the Qualifying Degree and original Surety Bond paper at the time of physical reporting to the IARI or its off-campuses. Students selected against SC/ST/OBC/EWS/UPS etc. category should produce all certificates as per the Government of India guidelines. If any candidate fails to provide/submit original certificates and/or additional documents, the provisional admission of the candidate will be cancelled and his/her claim for admission will stand forfeited.

Only limited hostel accommodation is available at IARI, New Delhi and its off-campuses. Hostel accommodation will be provided as per the stipulated guidelines and availability of rooms.

If at any time during the course of degree program, information furnished by the candidate is found to be incorrect or misrepresentation/concealment of facts, admission would be cancelled/forfeited and necessary action would be initiated against the candidate.

- Medical Certificate in case of Persons with Benchmark Disabilities (PwBD) candidate issued by Medical Officer of any Government Hospital along with description of the kind and the degree of disability.
- Anti-ragging Undertaking as available on www.antiragging.in
- > Surety Bond as attached along with the Notification
- It shall be mandatory for students to have medical insurance with minimum coverage of Rs. 3.00 lakhs per annum at the time of admission. The student has to mandatorily submit the policy document/beneficiary document viz. CGHS card, Aayushman card, Mediclaim etc. at the time of document verification failing which admission shall not be granted. In case, the student does not have the medical insurance, he/she has to pay Rs. 2811/- as a part of fees structure against which the student will be provided medical insurance by ICAR-IARI, New Delhi.

Note: Candidates are advised to bring 02 (two) copies of all above mentioned documents which should be self-attested.

FEES AND EXPENSES

ACCOMODATION POLICY

Hostel facility in ICAR-IARI, New Delhi and its off campuses is very limited and availability is not guaranteed. Allotment of the available hostel accommodation to the students will be as per the Institute Hostel allotment Policy and subject to availability of rooms. The hostel shall be allotted only for one semester at a time and shall be vacated at the end of each semester by the student. Students taking admission should be prepared to stay in the city if hostel accommodation is not available. Hostel charges shall be revised by the Institute each academic year. It will be obligatory for every hostel allottee to abide by hostel discipline rules which will be revised periodically. Student not complying with hostel or Institute rules and regulations shall be liable to appropriate disciplinary action as per Institute discipline policy.
