Any false declaration shall lead to termination.
2. No objection certificate (if employed) is also to be produced at the time of interview. The PTMO must declare if engaged in any other medical practice or consultancy elsewhere and must ensure that there is no conflict of interest.
3. No TA/DA is admissible for attending the interview and attending the duty or for any travel during the time of engagement unless explicitly approved by Competent Authority.
4. The candidate must be medically fit and is required to submit a medical fitness certificate at the time of engagement.
5. In case of any legal dispute, the jurisdiction shall lie in the court/boundaries of Delhi.
6. The terms & conditions shall be governed as per the ICAR O.M. No. 3(4)/95-Per.IV dated 3rd December, 2025 and any further orders issued by the Council from time to time.
