Applications are invited from eligible candidates for recruitment of **one Junior Research Fellow (JRF) and one Scientific Administrative Assistant/Field Worker** in a DBT funded project on “**Application of machine learning for hyperspectral imaging and remote sensing aimed at early detection of fungal foliar disease and bacterial wilt disease in potato crop**” purely on contractual basis at Division of Plant Pathology, ICAR-Indian Agricultural Research Institute, New Delhi-12.

### Terms and Conditions

1. The above position is purely temporary and will be filled on a contractual basis. The post is **co-terminus** with the project and will be offered initially for one year or until the termination of the project, whichever is earlier. It is further extendable based on satisfactory performance for the remaining project period.
2. For JRFs, the candidate age should be a maximum of 35 years, with an age relaxation of 5 years for SC/ST/Women & 3 years for OBC, applicable as per Govt. of India/ICAR Rules. **For Scientific Administrative Assistant/Field Worker, the upper age limit is 50.**
3. Only candidates with essential qualifications will be considered for the interview. No TA/DA will be paid to attend the interview.
4. On the interview date, all ELIGIBLE candidates need to be present 30 minutes before the scheduled time on the interview date for necessary formalities. Candidates reaching after the specified time may not usually be entertained. At the interview, the candidates have to submit their the duly filled-in application form (as per the format annexed), along with SELF-ATTESTED **photocopies** of **a)** date of birth certificate **b)** original or provisional certificates and mark sheets from matriculation onwards **c)** NET/equivalent certificate **d)** proof of experience **e)** publications **f)** no objection certificate from the employer/university, in case they are in employment elsewhere and **g)** **declaration**. **Upon joining**, the selected candidate must produce all the original documents and medical certificates. Concealing of facts or canvassing in any form shall lead to disqualification or termination of such candidates.
5. Selected candidates **will not be entitled** to claim for regular appointments/absorption either in this institute or in ICAR. Non-maintenance of discipline and failure to perform the assigned duties will make the candidate liable for termination during the appointment period as per ICAR rules.
