1. Interested and eligible candidates may appear in the Walk-In-Interview along with the annexed Application Proforma, together with relevant enclosures as mentioned in the proforma.
2. Details of the application form are published on the ICAR-IARI Contractual Job Web Portal (<https://iari.res.in/bms/announcements/jobs.php>). If space is insufficient, the Application Proforma could be typed neatly or additional information could be provided in Annexures, duly signed.
3. **The walk-in interview will be held on 13<sup>th</sup> February 2026 at 10:00 am in the Room No. 306, Division of Nematology.**
4. **Only the candidates having essential qualifications and proper certificates/ documents to support their candidature would be interviewed.** The candidates shall be shortlisted based on eligibility criteria, educational performance and/or relevant research experience, if applicable. No TA/DA shall be paid to attend the interview.
5. **Age Limit: 35 years maximum (5 years relaxation for SC/ST/Women candidates, 3 years to OBC candidates as per ICAR rules).** The post is purely temporary in nature and is co-terminus with the project.

6. The engagement will be purely on contractual basis, time bound, non-regular & co-terminus with the project and the incumbent shall not have any claim for regular appointment under ICAR or any further contractual engagement on termination of the project. The selected candidate shall have no legal right to claim regularization by absorption or otherwise or any further continued engagement on termination of the project.
7. The tenure of engagement will be for the term of the project, not extending beyond December 2026. The services of the incumbent shall stand terminated automatically on expiry of the period given in the offer letter. During the period of engagement, If the performance is non-satisfactory, the incumbent could be terminated from the position with one- month notice.
8. The candidates coming for interview must bring duly filled in application form, biodata, original certificates, attested photocopies of each of the certificates and an attested copy of recent passport size photograph. No TA/DA would be given for the appearance in interview.
9. The original documents of the selected/ wait listed candidates shall be checked in person, before the interview and also issue of the offer letter.
10. Medical fitness certificate would be required at the time of joining.
11. Candidates already engaged in employment in government/ PSU/ autonomous bodies etc, are required to furnish No Objection Certificate from the existing employer. Candidates currently pursuing a degree from any university are required to furnish No Objection Certificate from the Dean/Registrar of the university/institute.
12. Concealing of facts or canvassing in any form shall lead to disqualification of the candidature and/or termination of engagement even after appointment. In case of a dispute, the decision of Joint Director (Research), ICAR-IARI, New Delhi will be final and binding in all respects.
