





The President, Indian Council of Agricultural Research and Minister of Agricultural & Farmers Welfare is pleased to appoint you in the Agricultural Research Service (ARS) as Scientist (on probation) in Research Level 10 (₹ 57, 700/- ₹ 1, 82, 400/-) with rationalized entry pay ₹ 57, 700 on the basis of the results of ARS Examination, 2017 conducted by the Agricultural Scientists' Recruitment Board (ASRB), on provisional basis subject to Character & Antecedent and caste/tribe certificate verification.

This offer of appointment shall be governed by the following terms and conditions:-

1. Your appointment shall be regulated as per the service conditions of the Agricultural Research Service, Rules & Bye-laws of the ICAR Society and other Regulations/guidelines of the Council/ Govt. of India as amended from time to time. The ICAR follows the Government of India Rules and Regulations for all service and pension matters *mutatis-mutandis*.
2. The scale of pay of the post is Research Level to (₹ 57, 700/- ₹ 1, 82, 400/-). Your pay will be fixed at the minimum of the scale i.e. ₹ 57, 700/-.
3. In case you are holding Veterinary qualifications (B.V.Sc. / M.V.Sc.) you would be entitled for non-practicing allowance (N.P.A.) in accordance with Council's notification no. F.No. 1(4)/2017-Per.IV dated 27.03.2018 read with Ministry of Finance, Department of Expenditure O.M. No. 7(19)/2008-E-III (A) dated 30.08.2008 as amended from time to time.
4. You will be on probation from the date of appointment for a period of two years, which may be extended at the discretion of the Competent Authority. You will be required to report at NAARM, Hyderabad for undergoing Foundation Course / Training. Failure to



complete the training or the period of probation to the satisfaction of the Competent Authority will render you liable to be discharged from service.

5. If you are found to be guilty of conduct unbecoming of an ICAR employee during the period of training, you will be discharged even before the completion of the period of training.
6. You will be required to execute a bond to serve the Council for a minimum period of four years from the date of your appointment including the period of training in the enclosed proforma (which is to be typed on a stamped paper of appropriate value), **failing which you will have to refund an amount of Rs. 1.25 lakhs (Rupees One Lakh Twenty Five Thousands) together with interest thereon to the Council.**
7. As a member of ARS service, you will be liable to be posted to any ICAR Institute/Bureau/Centre/Project Directorate or its Regional/Sub-Stations, anywhere in India. You may be required to serve in a backward or less developed or remote area of the country for a period as may be decided by the Competent Authority.
8. The Council could depute you to work in a post under the Central or State Government, State Agricultural Universities or elsewhere (including assignments abroad) for a specific period, if need be depending on operational requirements.
9. On appointment, you will submit a declaration regarding your marital status in the prescribed form. **PROFESSIONAL CODE OF CONDUCT FOR TEACHERS**

  - (c) Refusal to carry out the decisions of the University authorities, academic bodies any functionaries of the University.
  - (d) Non-adherence to the highest standards of personal & professional ethics and/or indulging in plagiarism of any kind and sort, within the legal meaning interpretations & expressions of term.
  - (e) Director & tacit involvement in activities leading to :
    - (i) Disturbance of peace & harmonious community life on the campus including involvement & abetment in inciting students, staff and outsiders against other students, colleagues, administration and campus.
    - (ii) Spread of communal feeling, hatred, and campus violence including making derogatory remarks on caste, creed, colour, religion, race or gender.
    - (iii) In any activities, actions & deed adversely affecting or impinging upon the interest of the University.
  - (f) Nothing contained in these ordinances shall, however, interfere with the right of a teacher to express his/her views & difference of opinion on matters of principles in public forum, seminars, conferences, workshops and/or in his speech & writing.

**Note :- Failure to conform to the above "Professional Code of Conduct" will constitute misconduct on the part of the teacher.**






