

3.	Whether the serving employees working under Govt. of India are eligible for cashless treatment under different CGHS empaneled hospitals in Delhi & NCR?	Not related to IARI.
4.	Whether the serving employees working under ICAR head quarter and ICAR-IARI New Delhi are eligible for cashless treatment under different CGHS empaneled hospitals in Delhi & NCR?
