This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as Government Holiday, the bid due date will be next working day at the same time noticed as above.
- 2 Bids should be signed by bidder/himself / themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.
- 3 Bid forms are not transferable.

PAYMENT AND DELIVERIES.

- 13 The successful bidder will be required to make full payment of bid by bank Draft/pay order drawn on any nationalized bank in favor of Director, IARI, within 7 days thereafter. Earnest Money Deposit shall be forfeited if payment in full is not made or the offer is withdrawn during the validity period.
 - The successful bidder will have to lift the unserviceable items within seven days after depositing the full bid amount as per terms and conditions of the bid. Deliveries shall be affected against receipt of payment. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @ 10% of tendered value per week. The Institute will not be responsible for any loss or damage of the unserviceable items.
 - Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of period as mentioned above. Thereafter IARI shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.
