Technical Specifications

Name of the Capital item with brief description: Minus 80 Freezer

Detailed specifications:

- 1. Ultra-low temperature Freezer (-80 °C or more), Upright model with **400-500 liters** capacity, should have twin compressor based freezing.
- 2. Programmable microprocessor controlled with membrane keypad and easily accessible control panel; system should have programmable operating temperature from -50°C up to -80°C; system should have diagnostic software to identify any fault
- 3. Construction should be of good quality insulation with minimum of **four to five compartments** with **four to five independent inner doors**; Freezer should be quoted along with at least 9 inner racks and boxes of 2" or more (Inch); System should have top quality stainless steel interior chamber resistant to corrosion.
- 4. System should have heated air vent or vacuum release port and front mounted filter that is cleanable in the laboratory
- 5. Should have security keyed locks on the outer doors and lids keep out unauthorized users
- 6. System should have adjustable audible and visible alarms for temperature, power failure, system failure, battery low etc
- 7. System should have single condenser fan reduces energy consumption with CFC-FREE, HCFC-FREE nonflammable refrigerants, and refrigeration
- 8. System must be energy efficient refrigeration system; Freezer should have efficient power consumption not more than **10 to 15 kWh/day.**
- 9. Freezer should be quoted along with CO₂ Backup system its controller along with cylinder.
- 10. Single phase freezer should be supplied with 5KVA voltage stabilizer
- 11. Freezer must have **ISO 9001** standard quality test requirements; Must have **FDA approval** and **European CE certified** or **UL Certified**
- 12. One year warranty for the instruments and five year warranty on compressor
- 13. Optional: Data logging software for temperature monitoring system and pad lock should be quoted.

- Authorized dealer/supplier in India should enclose authorization certificate from the Principal
- On-site warranty minimum of 2 years from the date of installation
- Authorized dealer should have service centre in India
