## Annexure -A

### Technical Specifications of Mini Incubator (Small/Table top)

- The incubator should be having appropriate dimensions with a capacity of around 80l to use it as Table Top Mini Incubators
- The Incubator is to be suitable for biological samples like microbiological cultures, plant/animal tissues etc
- Digital display panel with keypad for inputs temperature setting
- It should be made of non corrosive double walled stainless steel sheet
- The interior shelves can be adjustable.
- They should be made of stainless steel fitted with fiberglass insulation provided on all five sides as well as between inner and outer walls and a silicon rubber door sealing to prevent heat loss and power drain.
- The exterior should be powder coated, durable, and corrosion resistant.
- The interior should have transparent door to facilitate product inspection and LED digital display to monitor chamber temperature
- Stainless steel interior chamber and shelves are to be corrosion resistant, durable and easy to clean
- It would be fitted with PID Temp. Controller for setting temperatures in the range of ambient  $\pm 5^{\circ}\text{C}$  to  $70^{\circ}\text{C}$ ; The temperature stability should be  $\pm 0.3^{\circ}\text{C}$  at  $37^{\circ}\text{C}$ ;  $\pm 0.4^{\circ}\text{C}$  at  $70^{\circ}\text{C}$ .
- It should have operational flexibility with compensation after load changes, setting changes or door opening for excellent accuracy.
- Incubator heater capacity : 700-750W
- It should ensure uniform distribution of natural heat convection with the adjustable air vents to provide excellent uniformity.
- Visual alarm indicator should be provided to alert extreme changes in set temperatures
- The specifications are generic in nature
