Online quotations are invited by Director, ICAR-Indian Agricultural Research Institute (ICAR-IARI) for appointment of "Consolidation-cum-Clearance Agent" hereafter called as 'Agent' from the date of appointment till 31.03.2022. The appointment shall be on basis on mutual consent basis subject to performance review by the Institute on the following terms & conditions. The last date for submission of quotation is 14/12/2021 by 01.00PM. The bid will be opened on 15/12/2021 at 02.30 PM

- Transport of goods/equipments envisaged be done <u>from ICAR-Indian Agricultural Research Institute (ICAR-IARI)</u>, New Delhi <u>to</u> Advanced Center for Agricultural Research & Education (ACARE), Yezin Agricultural University (YAU) Campus, Yezin, Nay Pyi Taw, Myanmaron <u>Delivered Duty Paid (DDP) basis</u> as per Incoterms <u>2020 both by sea & air</u>. A pictorial description of the Incoterms is enclosed as <u>Annexure 1</u> for ready reference of the bidders.
- ICAR-IARI shall only be responsible for providing Import License (IL)& Custom Duty Exemption Certificate (CDEC) to the agent's counterpart at Yangon i.e. the port of destination. All other expenses whatever required for the safe transportation and delivery of goods/equipment including insurance shall be within the scope of the bidder.
- Demurrages if any charges by the port authorities of Yangon because of delayed submission of IL & CDEC shall be additionally paid by YAU to the local clearing agent at Yangon against submission of original receipt from the government agencies. The bidder or its clearing agent will have to first make the payment of demurrage charges if any and clear the consignment. The same shall be reimbursed to the clearing agent by YAU at the time of door delivery.
- Bidders are mandatorily required to participate in all categories (A to H) mentioned in the enclosed BOQ as <u>Annexure 2</u>. In case of partial participation, the bid shall be treated as non-responsive. Lowest bidder (L1) shall be decided on the total of all unit rates.L1 will be offered to match the lowest bidder in each of the categories. If they do not agree match the lowest prices offered in a particular category by a different bidder, the said service category will have to be extended by the lowest bidder of the said category. The selection of lowest bidder (total as well as category basis) is illustrated in <u>Annexure 3</u> for better understanding of the bidders.
- The materials include research consumables and sensitive equipment. Entire material being transported will have to be suitably insured by the bidders. Lowest quoted insurance charges in the bid has to be compulsorily offered by each service provider irrespective of their quoted value. Damage to the materials if any will have to be paid for by the bidder to ICAR-IARI. ICAR-IARI shall not be responsible for making any such claim from the insurance company.
- Bidders must submit online the following documents along with their technical bid failing which their bids shall be declared non-responsive and summarily rejected.
 - 1. Copy of valid registration certificate with Customs for Custom House Agent (CHA) License.
 - 2. CHA must be registered in Custom house.
 - 3. The Bidder should have facility for custom clearance both for air & ship cargo.
 - 4. Firm should also be registered with the Indian custom as console agent & AEO (Authorized Economic Operator) for consideration of acceptance of bids. Bidder must have minimum 03 years regular working experience (atleast three in each calendar year) of Import/Export with GoI/ Defence/Central Govt PSU. Firms having lesser and irregular working experience shall not be considered. Copy of PO as proof must be essentially enclosed

- 5. A valid Certificate of IASA/IATA/FIATA stating that the bidder/its principal or counterparts is/are member of IASA/IATA/FIATA.
- 6. The tenderers are required to submit an undertaking with online tender that their firm has not been debarred/black listed/suspended by any Government /Autonomous Organization/PSU etc. in the prescribed performa (Annexure 4).
- 7. The firm have last three year experience (i.e. 2018-2019, 2019-2020& 2020-2021) for such service in Government Organization/Institutions and proof of Supply order for the same will be provided by the firm.
- 8. Proof of such type of supply not less than Rs. 30.00 lakhs during each financial year (i.e. 2018-2019, 2019-2020& 2020-2021) should be provided with the bid.
- 9. Copy of proof of turnover (balance sheet & profit & loss A/c only) of not less than Rupees 50.00 lakhs (Rupees Fifty lakhs) during the each of last three years viz2018-2019, 2019-2020& 2020-2021.
- 10. Copy of the (a) PAN CARD, (b) GST Certificate, (c) Latest GST Return (d) Trade License Certificate, if any.
- 11. The rates must be quoted according to the format (BOQ) only failing which tender will be ignored/rejected. D.O. charges on consignment coming under contract shall not be paid.
- 12. Scan copy of Bid Security Declaration at Annexure 5.
- 13. Original copies of Annexures 4 & 5 to be compulsorily submitted personally or by speed post/registered post/courier on or before the closing date of the tender to the following address. Non-receipt of the same on or before the closing date of the tender shall make the bidder non-compliant and the bid shall be rejected.

- The tender shall remain open for acceptance up to 180 days from the date of opening. After the acceptance of the tenders,
 the successful tenderer(s) will have to execute every supply order issued under this contract, within the stipulated period as
 specified in the supply order.
- The successful bidders shall deposit performance security of Rs. 1,00,000/-(Rupees One Lakh Only) in form of FDR/ Unconditional Bank Guarantee (BG)(as per prescribed format given at Annexure 6 of this tender document) from a commercial bank drawn in favour of Director, ICAR-Indian Agricultural Research Institute, New Delhi as Security money for the performance of the contract which should be valid at least for a period of 06 months alongwith contract agreement. No interest on Earnest Money or Security Deposit will be paid by the Institute. The same BG/FDR will be refunded / returned after successful completion of contract. However, the Director, ICAR- IARI will have the discretion to order for the forfeiture of deposit for any breach of contract.
- Contract Agreement: The successful bidder(s) will have to execute the prescribed contract agreement bond on the non-judicial stamp paper of Rs.100/- for the job in accordance with the conditions/stipulations to be given therein not later than 15th day from the date of acceptance letter, failing which the earnest money will be forfeited.
- In the event of any question, dispute/difference arising under the agreement orin connection herewith (except as to matters the decision of which is specially provided under this agreement) the same shall be referred to the sole arbitrator appointed by the Director, ICAR-IARI. The award of the arbitrator shall be final and binding on the parties.
- This contract between the supplier and the buyer shall be governed by the LAWS ofIndia and under this contract shall be taken by the parties only in ICAR-IARI to competent jurisdiction.
- Initially, the technical bids will be opened first and would be evaluated as per the laid down methodology. Thereafter, the financial bids of only those firms will be opened, who have qualified in the evaluation of their technical bids.
- If the work is suspended by force majeure conditions lasting for more than 1 (one) month, the Institute shall have the option of cancelling the Contract in whole or in part thereof at its own discretion. Any situation of force majeure shall not be payable any higher amount by the ICAR-IARI under any circumstances.

- The successful tenderer will have to give an undertaking that no consignment of ICAR-IARI will be detained/withheld by them before or after the clearance under any circumstances.
- Bids of firms who have not executed any contract satisfactory, failed to execute any such contract, have poor track record shall not be considered. Misrepresentation or suppression of facts will lead to cancellation of the bid.
- In case of any confusion, the parties should seek clarification about terms & conditions and pattern of formats, instead of quoting in ambiguous manner
- All disputes to be settled under New Delhi Jurisdiction.
- Online tender may please be submitted in two bid system i.e. **technical and financial bid**. Technical bid must contain required documents as per enclosed <u>Checklist as Annexure 7</u> and other Financial bid as per given format in BoQ must be uploaded on CPP Portal.
- Director, ICAR-IARI has full right to get services of any other consolidator/clearing agent for a particular consignment.
- Director, ICAR-IARI reserves the right to accept/reject any or all tenders without assigning any reasons thereof.
