<u>Instructions to bidders</u>

- **1. How to apply:** The OEM authorized, registered firm may apply against the bid floated for purchase of "GEOHECRAS 1D and 2D License Software (Workstation) for 1 seat and 2 years subscription" on GeM Portal. The firms must furnish full, precise and accurate details in respect of information asked for in the technical bid form of bid.
- **2. Estimated Bid value:** The estimated tender value is **Rs. 5.00 Lakh** approximately. Estimated bid value can be decreased.
- **3.** Earnest Money Deposit (EMD)/ Bid Security Not Applicable.
- 4. Performance Security Deposit: Not Applicable.
- **5.** Validity of the Bids: The tender submitted by the firm / agency shall remain valid for 45 days from the date of opening for the purpose of acceptance and installation of licence software. No firm will be allowed to withdraw/alter/modify after submission of tenders within the bid validity period.
