- 1. The rates quoted shall be valid for a minimum period of 180 days from the last date fixed for submission of bid
- 2. The rates quoted shall be free of cost delivery and installation at the Division/Unit of **Biochemistry**, IARI, New Delhi 110012. However, equipment quoted in foreign currency must be quoted on FOB/ CIP basis
- 3. Custom Duty Exemption Certificate (CDEC) will be issued only when the bid is quoted in foreign currency in case of foreign made items only and meant for IARI
- 4. Full specifications of the item/article quoted for shall be given in the quotation.
- 5. If taxes, duties or any other charges over and above the rates quoted livable, actual percentage of such taxes/duties/other charges should be clearly indicated.
- EMD of Rs. 8,000/- Rupees Eight thousand only) should be in the form of D.D./Pay Order/Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favors of Director, IARI payable at New Delhi.
