- 1. The rates quoted shall be valid for a minimum period of 180 days from the last date fixed for submission of bid.
- 2. Only those firms should respond who are the manufacturers or authorized dealers/agents of the stores specified in the tender specifications.
- 3. Indian agents of foreign manufacturers/principal are allowed to participate in the tender subject to the following conditions:
  - a) The Indian agent will submit along with the tender documents a copy of authority letter/agreement from the foreign manufacturer/principal for this particular offer.
  - b) Such agreement/authority with the foreign manufacturers/principal should be a long- term agreement and not merely for supply & Installation of the equipment.
  - c) If the agreement is only for the Supply & Installation, the offer received is liable to be rejected.

- 4. The rates quoted shall be free of cost delivery and installation at the Divison of Entomology, ICAR-IARI, New Delhi-110012. However, equipment quoted in foreign currency must be quoted on FOB.
- 5. Custom Duty Exemption Certificate (CDEC) will be issued only when the bid is quoted in foreign currency in case of foreign made items only and meant for IARI.
- 6. Full specifications of the item/article quoted for shall be given in the quotation.
- 7. If taxes duties or any other charges over and above the rates quoted leviable, actual percentage of such taxes/duties/other charges should be clearly indicated.
- 8. Bid Security Declaration in lieu of EMD as per Govt. Of India OM No. F.9/4/2020-PPD dated-12.11.2020 be submitted by firms other then the exepmted firms as per Govt of India rules to the Tender Inviting Authority along with technical bid document.
- 9. No interest on security deposit and earnest money deposit shall be paid by the Institute to tenderer.
- 10. In case of successful bidder, security deposit/performance security which is 3% of the order value in the form of D.D/Pay Order/Fixed Deposit Receipt/Bank Guarantee from commercial bank drawn in favour of Director, IARI, payable at New Delhi and shall remain valid for 60 days beyond the date of completion of all contractual obligation of supplier including warranty obligation for the equipment/goods costing Rs. 1.00 lakhs (Rs. One Lakh) or more. Here would however, be no performance security deposit for equipment/goods costing less than Rs. 1.00 lakh (One lakh).
- 11. Three years warranty has to be invariable provided by the firm. In case, there is any variation in the warranty period given in the specification of the item/equipment, the warranty period shall be the final as given in the specification.
- 12. Payment mode-

#### **A. FOR INDIGENOUS SUPPLIES:**

Payment through e-payment mode on bill basis after supply, satisfactory installation, commissioning and performance of the equipment at New Delhi and after certification by our Scientists/Indentor concerned.

#### **B. FOR IMPORTS SUPPLIES:**

The payment shall be made through irrevocable Letter of Credit (L.C.). LC will be opened on 100% value of the equipment/item on FOB/FCA value and 90% shall be released on presentation of complete and clear shipping documents. Rest 10% will be released only after satisfactory installation and commissioning of the equipment. This will not include commission to the Indian Agent. Payment to the Indian agent will strictly be made in Indian Rupees after satisfactorily commissioning of equipment's.

#### C. All bank charges:

All bank charges outside India will be borne by the supplier. In case the delivery date of the contract is extended to take care of delay in supply, for which the supplier is responsible, the tenure of the letter of credit it extended, the expense incurred on such extension is to be borne by the supplier.

13. Quotations not complying with the above conditions are liable to be rejected.

- 14. Scanned copy of TIN/VAT/PAN/C.S.T/GST Nos may be attached with the bid.
- 15. In case, any dispute arising out of this contract shall be subject to the jurisdiction of Indian laws & Court at New Delhi. Sole arbitrator is appointed by the Director, ICAR-New Delhi. His decision will be final and binding on both parties (Supplier and Purchaser).
- 16. The successful bidder has to execute the indented Job/Work as mentioned in the supply order place with them within the stipulated period as given in the supply order placed by this office failing with 2% per week and maximum of 10% deduction as liquidated damage charges will be made from the bill in case the job is not completed within the given stipulated period.

#### 17. Delivery time:-

- a. For Indian manufacturer Within 45 days from the Date of issue of award letter or as specified in the supply order.
- b. For Foreign firms 90 days from the date of opening of letter of credit (LC)
- 18. Full specification of the article quoted for shll be given in the quotation along with literature/pamphlet/drawing etc. User list of the quoted document may also be additionally provided for reference.
- 19. In Case, LC is opend for purchase of Foreign equipment all charges outside India will be borne by the firm.
- 20. - 21. The equipment is to purchase for Research purpose and therefore shall be purchased at concessional GST Rate of 5%. The required certificate shall be issued to the succefull bidder for availling concessional GST Rate.
- 22. The Director IARI, New Delhi reserves the right to accept or reject any or all the quotations either in full or in parts without assigning any reason.
