TERMS AND CONDTITIONS:

- 1. The interested party should submit their tender (in the Performa enclosed) to the undersigned in double sealed over. The outer cover should be super-scribed with the words "QUOTATION FOR UNSERVICEABLE ITEMS" due on 28.06.2019. The bid should be addressed to the Director, IARI, New Delhi and be deposited in the tender box kept in the office of AAO(s), Division of Agricultural Engineering on or before 28.06.2019 at 13.00 positively. This office shall not be responsible for any delay in postal transit. No bid shall be accepted after the due date and time. If the due date is declared as Government Holiday, the bid due date will be next working day at the same time noticed as above.
- 2 Bids should be signed by bidder/himself / themselves or a person duly authorized in this behalf. A copy of such authority should be enclosed along with the offer.
- 3 Bid forms are not transferable.
- 4 Bid will be opened on the same day at **3.00 P.M**. If the date of opening of bids happen to be holiday, then the bids shall be opened on the next working day at the same time.
- 5 Bidders can inspect the unserviceable items during office hours upto **27.06.2017 between 2.30 p.m. to 4 PM**. in regard to the conditions, of unserviceable items and satisfy themselves before submitting their offer by the date and time specified above.
- 6 Overwriting or alternations will also disqualify the bid unless these are legible attested by bidder/ bidders.
- 7 Rate should be kept valid for acceptance at least for **180 days** from the date of opening.
- 8 Other levy if any will have to be paid by the successful bidder.
- 9 Earnest Money deposit (EMD): Each bid should be accompanied by an earnest money of **Rs.3500.00** drawn in favor of the **Director, IARI**, in the shape of Demand Draft / Pay order/FDR/Bank Guarantee from any Commercialized Bank. The bidders are advised to quote the bid amount (both in words and figures)

- 10 It will be presumed that the bidders before submitting the offer have read carefully all the terms and conditions and accepted the same in full. Deviations from the terms and conditions as given in this are not permitted. Any such conditional bid and / or telegraphy bid is liable to be rejected and no alternations shall be allowed after the bid is submitted. No counter terms and condition shall be accepted.
- 11 Right to include any other conditions or modify or alter any of bid conditions already stipulated is reserved by the Director, IARI, New Delhi -12
- 12 Bidder will be deemed to have been on the clear understanding that they have satisfied themselves fully in regard to the conditions, quality and quantity of unserviceable vehicles proposed to be auctioned.

13 PAYMENT AND DELIVERIES.

The successful bidder will be required to make full payment of bid by bank Draft/pay order drawn on any nationalized bank in favor of Director, IARI, within 7 days thereafter. Earnest Money Deposit shall be forfeited if payment in full is not made or the offer is withdrawn during the validity period.

The successful bidder will have to lift the unserviceable items with in seven days after depositing the full bid amount as per terms and conditions of the bid. Deliveries shall be affected against receipt of payment. Any purchaser failing to lift the material within the above stipulated period, shall have to pay ground rent @ 10% of tendered value per week. The Institute will not be responsible for any loss or damage of the unserviceable items.

Earnest money deposited shall be forfeited if any purchaser fails to lift the items after making full payment and expiry of period as mentioned above. Thereafter IARI shall be entitled to resell these items. No notice shall be issued to the bidder in this regard.

- 14 The purchaser will not be entitled to resell any or all unserviceable items while these are still lying within the premises of IARI and no delivery would be affected by any person or persons other than the purchaser/purchasers whose name/names are mentioned in the delivery order.
- 15 The successful bidder before actually collecting purchased unserviceable items should contact the Assistant Admn.Officer, Division of Agricultural Engineering, IARI, New Delhi -12 to get the gate pass and delivery of unserviceable items.
- 16 Loading, handling, lab our and transportation shall be the sole responsibility of the purchaser at his own cost, rest and arrangement.
- 17 Loading and lifting of the auctioned goods shall be done by the purchaser only during the prescribed working hours of the Institute No deliveries shall be affected during Sunday or Holiday.
- 18 The Director, IARI, New Delhi reserve the right accept or reject any or all offer/bids either in full or in part without assigning any reason whosoever.
- 19 If, sufficient bids are not received, the Director, IARI, New Delhi reserves the right to call for fresh bids. In such an event Earnest Money deposited by the bidder shall be refunded.
- 20 The Earnest Money deposited by the successful bidder shall be refunded in full without any interest.
- 21 The unserviceable items will be sold on 'AS IS WHERE IS' basis and no guarantee for its worthiness of quality will be given by the Institute. The tender

will be rejected if the same is found fictitious and the Earnest Money will be forfeited.
The successful bidder shall be responsible for any damage that may be done to the premises while removing the goods by him. The Director, IARI, may at his own options ask to make good such damages and buyer shall have to pay for the same on demand.
